Meeting Date: March 16, 2015

Arlington Village Council met in regular session at 7:00 p.m. with Mayor Solt presiding. Council members Blunk, Dempster, Essinger, T.J. Huffman, T.L. Huffman, and Palmer were present. Also present were Monday, Crist, Best, Latta and Rasmussen.

The meeting was called to order and followed by the Pledge of Allegiance.

Motion by Blunk and second by T.J.Huffman to approve the March 2nd meeting minutes. Voice vote, all yes. Motion carried.

Visitors: Lisa Hays, Lisa Huston and Lori Mills, members of the Arlington Village Festival, had Mayor Ed Solt draw the ticket for the beef raffle. 356 tickets were sold and the winner was J.D. Richards. Also passed out sponsorship letters and gave times of the festival. **Don Bash** 602 N Main Street, was here to discuss zoning at his property over a building he would like to build.

Personnel Reports:

Latta (Fire) – June 26th will be the fireworks. Rehiring of Matt Haugh, putting a plan together to re-instate.

Monday (Water & Sewer) – everything is thawed out, had to do additional water testing this past weekend. Will be flushing hydrants Monday, April 20 and Tuesday, April 21st from 6-9pm.

Crist (Streets & Parks) – getting ready for spring. April 21 part-time employee starting. April 3-15 will be on vacation- unavailable. Is going to be ordering pool chemicals shortly and getting restrooms up and going.

Best (Board of Public Affairs) – Consumer confidence reports being printed out.

Motion by Palmer second by T.J. Huffman to approve cash summary by fund report. Voice vote, all yes. Motion carried.

Motion by Essinger and second by Dempster for adjournment. Voice vote, all yes. Motion carried.
