Meeting Date: October 3, 2016

Arlington Village Council met in regular session at 7:00 p.m. Council Members Bell, Smith, Blunk, Huffman and Dempster were present. Also present were Monday, Dean Glick, Beidelschies Latta and Greg Glick.

Mayor Palmer called the meeting to order followed by the Pledge of Allegiance.

Motion by Blunk seconded by Dempster to approve the minutes from the September 19, 2016 meeting. Voice vote, all yes. Motion carried.

Visitors:

Dan and Stephanie Rader, Nick Clevidence and Sheriff Deputy Otto. Deputy Otto gave an update from the Sheriff's Department.

Personnel Reports:

Latta (Fire) – Gave an update on Fire Department operations.

Monday (Water & Sewer) – S. Cumberland water line repaired, will be attending a waste water seminar on October 18th and will be on vacation on 10/6, 7 and 10.

Dean Glick (Streets & Parks) – Discussed vandalism that occurred over the past week, getting quotes for pool concrete repairs, pool house/pump house roof replacement and drainage repairs.

Beidelschies (Board of Public Affairs) – Answered questions concerning new water meters.

Greg Glick (Fiscal Officer) – Gave updates on finance and status of Sheriff patrol contract.

Rasmussen (Solicitor) – Presented 2 ordinances for Council consideration.

Fahy (Blanchard Design Associates) – Led additional discussion on potential zoning changes, gave a route 68 update and will attend next BPA meetings where new meters will be discussed.

Committee Reports:

Huffman (Finance, Fire & Capital Projects) – Reviewed prior audit recommendation. Expressed concerns about finances and the Sheriff patrolling contract.

Dempster (Maintenance, Safety, EMS & Street Lights) – No report.

Bell (Community Development & Business Relations) – No Report.

Essinger (Water, Drainage & Sewer) – Not present.

Blunk (Parks, Recreation & Trees) – Informed Council there will be public hearings about the proposed Park/Pool Levy on 10/15 at 10:00 am at the Pool and 10/24 at 6:30 at the Municipal Building.

Smith (Streets, Sidewalks & Zoning) – Expressed concerns with grass clippings being blown into the Streets and getting into catch basins and properties with high weeds.

Palmer (Mayor) – Will follow up on a request for Arlington to be considered a Hancock County Purple Heart Village.

Old Business:

Smith expressed concerns about Council Members missing meetings.

New Business:

Motion by Huffman seconded by Dempster to revise pages 9, 26, 30 and 31 of the personnel manual. Voice vote, all yes. Motion carried.

Clerk gave first reading of Ordinance 2016-15 an ordinance amending the Village of Arlington, Ohio zoning code and the zoning code map by rezoning Lot Number 46 W1/2 and 47 in the Camerons Addition to the Village of Arlington, Ohio from R2 One Family Residential District to B-3 Community Business District.

Clerk gave first reading of Ordinance 2016-16 and ordinance authorizing the fiscal officer to reimburse the street commissioner each month for the cost of his health insurance coverage in an amount up to \$300 each month. Motion by Dempster and second by Blunk to suspend the rules and give Ordinance 2016-16 its second and third readings. Roll call vote, all yes. Motion carried. Clerk gave second and third readings of Ordinance No 2016-16. Motion by Dempster and second by Bell to adopt Ordinance 2016-16. Voice vote, all yes. Motion carried.

With funds currently available to pay all obligations and funds available when the obligations were incurred, Motion by Huffman seconded by Bell to approve payment of the bills as presented (listing attached). Voice vote, all yes. Motion carried.

Motion by Dempster seconded by Huffman to approve the Cash Summary by Fund through September 30, 2016. Voice vote, all yes. Motion carried.

Motion by Huffman and second by Blunk for adjournment. Voice vote, all yes. Motion carried.
