Old Business:

Gave third reading of Ordinance No. 2018-13 increasing the Mayor's compensation from \$3500-\$3700 per year. Motion by Huffman seconded by Smith to approve Ordinance 2018-13. Voice vote, all yes. Motion carried.

New Business:

Motion by Smith seconded by Huffman to approve Jacob Hunt and Darin Hefner as new fire fighters. Voice vote, all yes. Motion carried.

Motion by Essinger seconded by Smith to approve payment of \$500 deductible for damage to the Fire Station. Voice vote, all yes. Motion carried.

Motion by Smith seconded by Essinger to contract with Concrete Protection to resurface the Fire Station floor. Voice vote, all yes. Motion carried.

Motion by Clevidence seconded by Smith to approve a reduction of \$94.25 in the sewage bill of B. Green. Voice vote, all yes. Motion carried.

Motion by Essinger seconded by Clevidence to contract with Neff Construction to clean the creek near the sewage plant at a cost of \$1,300. Voice vote, all yes. Motion carried.

Motion by Dempster seconded by Waltermire to contract with Green Farm Tree for the removal of 8 trees at a cost of \$418. Voice vote, all yes. Motion carried.

Motion by Huffman and second by Smith to approve the cash summary by fund as of May 31, 2018. Voice vote, all yes. Motion carried.

With funds currently available to pay all obligations and funds available when the obligations were incurred, Motion by Essinger seconded by Huffman to approve payment of the bills as presented (listing attached). Voice vote, all yes. Motion carried.

Motion by Essinger and second by Clevidence for adjournment. Voice vote, all yes. Motion
