Clerk gave third reading of Ordinance 2019-10 levying a 1.7 mill assessment for street lighting. Motion by Essinger and seconded by Smith to approve Ordinance 2019-10. Voice vote, all yes. Motion carried.

New Business:

Motion by Essinger and seconded by Smith to excuse Mayor Palmer from the meeting. Voice vote, all yes. Motion carried.

With funds currently available to pay all obligations and funds available when the obligations were incurred, Motion by Essinger seconded by Huffman approve payment of the bills as presented (listing attached). Voice vote, all yes. Motion carried.
