Motion by Latta and seconded by Dempster to contract with Kramer Excavating to make drainage improvements on Mountain Ash Dr. at a cost of \$4,340 to be paid from the General Fund. Voice vote, all yes. Motion carried.

Motion by Latta and seconded by Bell to contract with Kramer Excavating to clean the ditch between Powell Dr. and Cedar Ln. at a cost of \$3800, to be paid from the General Fund. Voice vote, 5 yes; Dempster no. Motion carried.

Motion by Dempster and seconded by Barker to approve the cash summary by fund as of September 30, 2021. Voice vote, all yes. Motion carried.

With funds currently available to pay all obligations and funds available when the obligations were incurred, Motion by Bell seconded by Latta to approve payment of the bills as presented (listing attached). Voice vote, all yes. Motion carried.
