Motion by Barker and seconded by Dempster to permit an Easter Egg Hunt to be held in the Village Park on April 1, 2023 and permit food trucks in the Park during the event with a charge of \$25 for water and \$25 for electric for each truck if needed. Roll call vote, all yes. Motion carried.

Motion by Dempster and seconded by Latta to provide a credit of \$107.25 to the Sewer bill of Kell Buerger 107 N. Main St. Voice vote, all yes. Motion carried.

Motion by Sparks and seconded by Dempster to hire Shelly Heacock as BPA Clerk effective immediately at a rate of \$10,000 per year. Voice vote, all yes. Motion carried.

Motion by Sparks and seconded by Barker to pay Ron Bower his regular salary for March 2023 plus \$40 per hour for training the new BPA Clerk. Voice vote, all yes. Motion carried.

Motion by Dempster and seconded by Huffman to contract with Wyroc to replace 2 heaters in the storage area of the Street building at a total cost of \$6,200. Voice vote, all yes. Motion carried.

Motion by Barker and seconded by Latta to donate a 2024 season swimming pool pass to be given away at the 2023 Village Festival. Voice vote, all yes. Motion carried.

Motion by Latta and seconded by Dempster to contract with Helms Excavating for the 2023 street resurfacing at a cost of \$49,891. Voice vote, all yes. Motion carried.
