Fiscal Officer gave first reading of Ordinance 2023-04 a 1.7 mill special assessment for Street Lighting.

Fiscal Officer gave first reading of Ordinance 2023-05 a 1.3 mill special assessment for Street Repair.

Motion by Dempster and seconded by Bell to provide \$23.75 in sewer bill credit to Leslie Bowling, 122 Waterloo. Voice vote, all yes. Motion carried.

Motion by Sparks and seconded by Barker to contract with Cory Green to cut the weeds on the Village portion of the ditch bank from the rear entrance of the Park to Main Street at a cost not to exceed \$1500. Voice vote, all yes. Motion carried.

With funds currently available to pay all obligations and funds available when the obligations were incurred, Motion by Huffman and seconded by Barker to approve payment of the bills as presented (listing attached). Voice vote, all yes. Motion carried.
