Fiscal Officer gave first reading of Ordinance 2025-02 transferring \$35,000 from the General Fund to the Capital Improvement Fund. Motion by Dempster and seconded by Barker to suspend the rules and give Ordinance 2025-02 its second and third readings. Roll call vote, all yes. Motion carried. Fiscal Officer gave second and third readings of Ordinance 2025-02. Motion by Dempster and seconded by Lotz to adopt Ordinance 2025-02. Voice vote, all yes. Motion carried.

Fiscal Officer gave first reading of Ordinance 2025-03 establishing the Enterprise Inspection and Infiltration Fund (Fund 5901). Motion by Tyzzzer and seconded by Latta to suspend the rules and give Ordinance 2025-03 its second and third readings. Roll call vote, all yes. Motion carried. Fiscal Officer gave second and third readings of Ordinance 2025-03. Motion by Sparks and seconded by Lotz to adopt Ordinance 2025-03. Voice vote, all yes. Motion carried.

Fiscal Officer gave first reading of Ordinance 2025-04 transferring \$20,000 from the General Fund to the Inspection and Infiltration Fund. Motion by Lotz and seconded by Barker to suspend the rules and give Ordinance 2025-04 its second and third readings. Roll call vote, all yes. Motion carried. Fiscal Officer gave second and third readings of Ordinance 2025-04. Motion by Dempster and seconded by Sparks to adopt Ordinance 2025-04. Voice vote, all yes. Motion carried.

Motion by Latta and seconded by Barker to approve disposal of 2019 records (list attached). Voice vote, all yes. Motion carried.

Motion by Sparks and seconded by Tyzzzer to provide a \$13 credit to the sewer bill of Tony Cole, 114 W. Main Cross St. Voice vote, all yes. Motion carried.

Motion by Dempster and seconded by Lotz to approve Martin Jones as a new Volunteer Fire Fighter. Voice vote, all yes. Motion carried.

Motion by Dempster and seconded by Latta to appoint Barker and Lotz to the Volunteer Firefighters Dependents Fund Board. Voice vote, all yes. Motion carried.

Motion by Sparks and seconded by Dempster to approve paying up to \$2500 for freight on fireworks for the 4th of July display. Voice vote, all yes. Motion carried.

Discussion was held on placing Narcan in the Park. With no motion or second on this matter it will not be placed in the Park.

Motion by Sparks and seconded by Tyzzar to allow for \$450 per month reimbursement for employee health insurance premiums for the Village's full time employees, effective February 1, 2025. Voice vote, all yes. Motion carried.

Motion by Barker and seconded by Latta to approve the Cash Summary by Fund as of December 31, 2024. Voice vote, all yes. Motion carried.

With funds currently available to pay all obligations and funds available when the obligations were incurred, Motion by Dempster and seconded by Lotz to approve payment of the bills as presented (listing attached). Voice vote, all yes. Motion carried.
