Motion by Sparks and seconded by Lotz to approve 2025 compensation increases effective with the pay period that includes March 1, 2025 (See attached list). Voice vote, all yes. Motion carried.

Motion by Sparks and seconded by Barker to replace the fence gate on field one at a cost of \$1290. Voice vote, all yes. Motion carried.

Motion by Dempster and seconded by Barker to add cameras at the main square on Main Street at a cost of \$674.99. Voice vote, all yes. Motion carried.

Motion by Dempster and seconded by Latta to add Tilapia to the sewer lagoons at a cost of \$947.50. Voice vote, all yes. Motion carried.

Motion by Lotz and seconded by Latta to approve the Cash Summary by Fund as of January 31, 2025. Voice vote, all yes. Motion carried.
