Arlington Village Council met in regular session at 7:00 p.m. Council Members Dempster, Barker, Tyzzer, Lotz, Latta and Sparks present. Also present were Feighner, Fahy, Huffman, Beidelschies and Glick.

Mayor Palmer called the meeting to order and followed by the Pledge of Allegiance.

Motion by Barker seconded by Latta to approve the minutes from the February 17, 2025 regular meeting. Voice vote, all yes. Motion carried.

Visitors:

Mitch Heacock was present to discuss using the Park concession stand by the Rec Council.

Personnel Reports:

TJ Huffman (Fire) – Provided an update on Fire Department operations.

Jamie Insley (Zoning Inspector) – Not present.

Beidelschies (Board of Public Affairs) – Provided an update on BPA activities.

Rob Feighner (Solicitor) – Provided an update on legal matters.

Greg Glick (Fiscal Officer) – Provided an update on Village finances.

Fahy (Village Engineer) – Provided an update on Village projects.

Committee Reports:

Lotz (Finance, Fire & Capital Projects) – Discussed renewing the 2 fire levies for another 5 year period.

Dempster (Maintenance, Safety and Trees) – Gave an update on EMS operations.

Sparks (Community Development, Business Relations, & Zoning) – Has been asked if the School would be required to place fences around drainage ponds.

Barker (Parks & Recreation) – Reported the new playground has been installed and asked if there were plans for a trash day.

Latta (Streets, Alleys, Sidewalks & Trees) – 2025 Street paving will begin June 16th. New dump truck should be ready next month.

Tyzzar (Water, Drainage & Sewer) – There are no plans for a sewer rate increase.

Palmer (Mayor) – Discussion was held on various properties that need addressed for junk and run down conditions. Discussed an issue with income tax refunds. The Mayor will work with the Findlay Income Tax Department to clarify

Old Business:

Discussion was held concerning animals owned by Village residents. Feighner will bring sample ordinances to the next meeting.

New Business:

Fiscal Officer read Resolution 2025-01 consent legislation for installing a cross walk signal on Main Street at Park and Deerfield Streets. Motion by Latta and seconded by Sparks to approve Resolution 2025-01. Voice vote, all yes. Motion carried.

Motion by Barker and seconded by Dempster to contract with USA Lawn, at a cost not to exceed \$11,134, to treat grass areas and weeds at ball fields in the Park until Ben Slough receives his spraying license. Voice vote, all yes. Motion carried.

Motion by Barker and seconded by Latta to approve adding a ceiling to the small shelter house at a cost of \$277.04. Voice vote, all yes. Motion carried.

Motion by Latta and seconded by Barker to allow the Rec Council access to use the North concession stand at the Park for the 2025 season. Village Council will be responsible for ensuring the building is ready for use. Rec Council will be responsible for purchasing and maintaining all equipment, keeping the concession stand clean and picking up trash. Village Council will waive the 30% fee on profits for 2025. Voice vote, 5 yes, Sparks no. Motion carried.

Motion by Latta and seconded by Tyzzar to approve the Cash Summary by Fund as of February 28, 2025. Voice vote, all yes. Motion carried.

With funds currently available to pay all obligations and funds available when the obligations were incurred, Motion by Latta and seconded by Dempster to approve payment of the bills as presented (listing attached). Voice vote, all yes. Motion carried.

Motion by Sparks seconded by Tyzzar for adjournment. Voice vote, all yes. Motion carried.
