Committee Reports:

Lotz (Finance, Fire & Capital Projects) – Suggested borrowing \$500,000 of the \$700,000 needed for the new water tower.

Dempster (Maintenance, Safety and Trees) – Suggested trash day is July 26 from 7:00 am to 11:00 am. Recommended contracting with Pine Ridge Pest Control for mosquito spraying.

Sparks (Community Development, Business Relations, & Zoning) – No report.

Barker (Parks & Recreation) – Distributed quotes for cleaning area ditches. Suggested waiving the fee for the Festival Committee using the shelter house in October. Festival Committee has asked for a 2026 family pool pass to be given away at the Festival.

Latta (Streets, Alleys, Sidewalks & Trees) – Discussed alleys to be paved this Summer, and street sweep schedule for Ben Suever.

Tyzzer (Water, Drainage & Sewer) – No report.

Old Business:

Discussion on animal ordinances – No action is planned.

New Business:

Fiscal Officer gave first reading of Ordinance 2025-06 the 1.3 mil special assessment for street lighting.

Fiscal Officer gave first reading of Ordinance 2025-07 the 1.7 mil special assessment for street repair.

Motion by Barker and seconded by Tyzzer to approve the Fire Departments Junior Fire Fighter Program. Voice vote, all yes. Motion carried.

Motion by Latta and seconded by Dempster to approve the fire contract rates for the next 3 year. Voice vote, all yes. Motion carried.

Motion by Dempster and seconded by Latta to approve July 26 for 2025 Trash Day. No paint, tires, batteries, tube tv's and no construction debris. Voice vote, all yes. Motion carried.

Motion by Dempster and seconded by Tyzzer to contract with Pine Ridge Pest Control for mosquito spraying at a cost not to exceed \$4000 for the year. Voice vote, all yes. Motion carried.

Motion by Barker and seconded by Latta to contract with Green Excavating for ditch chopping at a cost of \$3177.50. Voice vote, all yes. Motion carried.

Motion by Barker and seconded by Dempster to donate a 2026 family pool pass to the Festival Committee. Voice vote, all yes. Motion carried.

Motion by Barker and seconded by Latta to waive the shelter house fee for an event in October by the Festival Committee. Voice vote, 5 yes; Tyzzer abstained. Motion carried.

Motion by Sparks and seconded by Tyzzar to dispose of grinding for the 2025 paving project in the most efficient manner possible. Voice vote, all yes. Motion carried.

Motion by Latta and seconded by Sparks to approve the Cash Summary by Fund as of April 30, 2025. Voice vote, all yes. Motion carried.

With funds currently available to pay all obligations and funds available when the obligations were incurred, Motion by Dempster and seconded by Barker to approve payment of the bills as presented (listing attached). Voice vote, all yes. Motion carried.

Motion by Sparks seconded by Dempster for adjournment. Voice vote, all yes. Motion carried.
