

**Preliminary Consent Legislation**

**Ordinance # 2017-10**

**County/Route/Section: HAN SR 37/103/698-2.57/8.03/0.25**

The following is an ordinance enacted by the Village of Arlington, Hancock County, Ohio, hereinafter referred to as the Local Public Agency (LPA), in the matter of the stated described project.

**SECTION I - Project Description**

WHEREAS, the LPA has identified the need for the described project:

This project proposes to mill and pave asphalt on the following State Routes:

- On SR 37 from the east corporation limits of the City of Findlay to just south of the SR 15 interchange
- On SR 103 from west corporation limits to the east corporation limits of the Village of Arlington
- On SR 698 from the south corporation limits to the north corporation limits of the Village of Jenera

WHEREAS, a portion of the described project is within the village corporation limits.

NOW THEREFORE, be it ordained by the Village of Arlington of Hancock County, Ohio.

**SECTION II - Consent Statement**

Being in the public interest, the LPA gives consent to the Director of Transportation to complete the above described project.

**SECTION III - Cooperation Statement**

The LPA shall cooperate with the Director of Transportation in the above described project as follows:

ODOT and FHWA shall assume and bear 100% of the necessary costs of the State's highway improvement project. In the event that the village requests certain features or appurtenances to be included within the State's highway improvement project's design and construction, and which features and appurtenances are determined by the State to be not necessary for the State's project, the village shall contribute 100% of the cost of those items.
