

ORDINANCE NO. 2019-01

AN ORDINANCE TO MAKE APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF ARLINGTON, STATE OF OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2019, REPEALING ALL ORDINANCES IN CONFLICT HEREWITH, AND DECLARING AN EMERGENCY

BE IT RESOLVED by the council of the Village of Arlington, State of Ohio, two-thirds (2/3) of all members elected thereto concurring:

SECTION 1: That all ordinances in conflict herewith be and the same hereby are repealed.

SECTION 2: That to provide for the current expenses and other expenditures of the said Village of Arlington during the fiscal year ending December 31, 2019, the following sums be and they hereby are set aside and appropriated as follows:


