## AN ORDINANCE TO MAKE APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF ARLINGTON. STATE OF OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2021, REPEALING ALL ORDINANCES IN CONFLICT HEREWITH, AND DECLARING AN EMERGENCY
